#### PROVISIONS FOR ACCESSING TO THE WORKSHOP

In the interests of all participants and in conformity with current Coronavirus and health and safety legislation, we would ask you to please observe the following directions regarding access to the Workshop. **Green Passes** ("Green Covid-19 Certification" with at least one of the following: A certificate of vaccination, even with the first dose only, dated within the previous 14 days; proof of a negative PRC (molecular) or rapid lateral flow (antigen) test during the previous 48 hours). Visitors from other countries may enter and remain in Italy for work purposes for up to 120 hours. Anybody recording a temperature equal or over **37.5°C** will be refused entry. Body temperature checks will be in operation, and particular attention will be paid to the **hygiene and sanitising** of all the spaces. Wearing of **masks** is mandatory during the event. At least 1 metre **social distancing** must be observed.
